Applications are invited from the permanent residents of Jammu & Kashmir State for admission to one year heritage craft course in "**Basohli Painting**" for the session 2017-18 commencing from September, 2017. The candidates who desire to apply for admission must possess graduation in any stream. The application forms can be had from the office of the undersigned as well as on the official website of this institution and can be obtained free of cost. The application forms should be accompanied with following self-attested copies:

- I) State Subject/ PRC
- II) Marks certificate of qualifying examination
- III) D.O.B. certificate
- IV) Category certificate, if any viz; SC/ ST/ OBC/ Ex-Serviceman/ PH
- V) Two recent self attested Passport size photographs

The last date of submission of application form : **18.09.2017** upto 02:00 PM

Date of counselling : **19.09.2017** (12:30 PM)

The classes shall be started from **20th of September, 2017.**

The following criteria shall be observed for making admission in the said courses.

- ✓ The candidate must be permanent resident of Jammu and Kashmir State.
- ✓ The minimum age of the candidate applying for admission is 14 years. However, there is no upper age limit to apply for admission in the said trade.
- ✓ The candidate must possess Graduation in any stream.
- ✓ The selection shall be made on the basis of academic merit obtained by the applicants in Graduation.
- ✓ Preference shall be given to the women candidate.

Salient Features

- ♣ The trainees shall be provided Financial Assistance up to Rs.2000/- per month to meet their to and fro transport expenses etc. during the training course.
- ♣ The trainees shall be taken to different locations for on-the-job training. The cost of such visits shall be borne by the Department.
- ♣ After the successful completion of training courses, the trainees shall have to appear in the prescribed examination and the certificates shall be awarded by the State Council for Vocational Training (SCVT).
