### **Terms and Conditions:-**

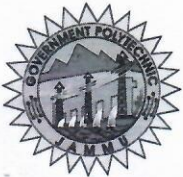
1. The total intake capacity is 25 seats under the Centrally Sponsored PWD Scheme and out of which 15% seats are reserved for the female candidates.
2. The candidate must be permanent resident of Jammu and Kashmir UT.
3. The candidate must have passed Matriculation/ Secondary School Examination or any equivalent examination from a recognized statutory Board/ University with not less than 35% marks.
4. The candidates must have Disability Certificate from Chairman District Medical Board with minimum percentage of Disability of 40% or above.
5. There is no age bar for admission to Diploma Courses in Polytechnics of J&K UT.

### **Certificates to be attached (Photo copies duly Attested):-**

- a) Marks certificate of the qualifying examination (10<sup>th</sup> Class)
- b) Disability Certificate issued by the competent authority clearly specifying percentage of disability which should be 40% or above bearing proper dispatch number and date of issue.
- c) Domicile certificate issued to authority of J&K UT.
- d) Category certificate if any.
